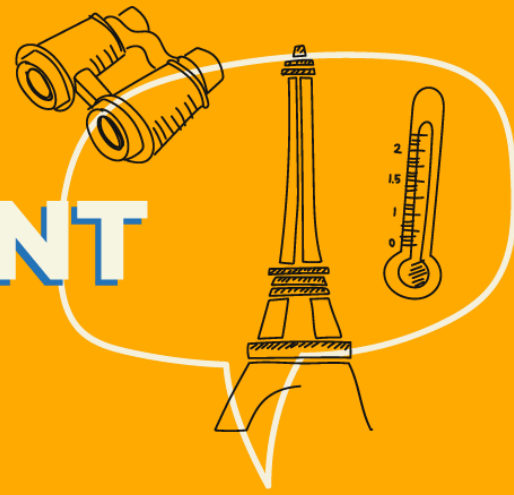


# PARIS AGREEMENT MONITOR



Bulletin #25 (English #4) - November/2024

## Introduction

*This is the Monthly Bulletin of the Paris Agreement Monitor, which tracks the key developments in the Paris Agreement negotiation process, including meetings, workshops, official statements, submission deadlines, and document publications. The reported developments are those that occurred up until the last day of the reference month.*

*The Bulletin presents **retrospective updates** related to the previous month, and **future updates** concerning the current month, based on the publication of documents and event schedules available on the official agendas of the UNFCCC website. It also includes open deadlines and document submissions by the Parties and UNFCCC bodies.*

*The developments are categorized according to the main thematic pillars of the Paris Agreement negotiations: Mitigation, Adaptation, Loss and Damage, Carbon Markets, Finance, Forests, Gender, Transparency, Global Stocktake, Compliance, Technical Capacity Building, Response Measures, Local Communities and Indigenous Peoples, Action for Climate Empowerment, Research, Technology, and Just Transition. For issues concerning the entire negotiation process and the UNFCCC system, we use the General category.*

*At the end of the edition, you will find a glossary with the most frequently used terms in the document.*

*The updates are reported in a way that describes the events and their relevance in the negotiation process. For more in-depth information on the content of the discussions at each described event, you can access the links provided in the updates. The links refer to the original transcript of the mentioned documents, meeting agendas and minutes, submitted documents, event recordings, referred technical reports, and official event web pages. All disclosed information is official and obtained through the UNFCCC website.*

## Happened in October:

### General

**Event Type:** Publication.

**Subject:** Appointment of Ministerial Pairs for informal consultations.

**Date:** October 8<sup>th</sup>, 2024.

**Involved Body:** Presidency of the COP.

**Summary:** The Presidency of the COP informed the appointment of ministerial pairs to conduct the informal consultations before and during COP 29, as follows:

**(i)** On mitigation: Tore Onshuus Sandvik (Norway) and Dion Travers George (South Africa).

Guiding questions:

What elements of an implementable outcome do you expect to be part of an overall package on mitigation at COP29?; and

How can we harness the results from relevant work to shape the mitigation outcome at COP 29?

**(ii)** On adaptation: Eamon Ryan (Ireland) and Franz Tattenbach (Costa Rica).

Guiding questions:

What does it take to elevate adaptation to the level of urgency and support it demands and to catalyze the adaptation landscape? What do you believe should be the outcomes of this first year of the UAE-Belem Work Program?

Given the large diversity of modalities and channels for adaptation action and support, what arrangements can catalyze a periodic assessment of the adaptation landscape in a way that can ensure synergy alignment and informed decision-making?

**(iii)** On Article 6: Grace Fu Hai Yien (Singapore) and Simon Watts (New Zealand).

**Guiding questions:**

What convergence and/or resolution is needed to finalize guidance for the issues of (a) authorization for ITMOs and A6.4ERs; and (b) on registries?

Since there are multiple ways to report information on participation in cooperative approaches, can parties be given flexibility in their approach to authorization?

Are changes or revocations to authorization permissible, and if so, when and under what circumstances?

Can the UNFCCC-provided Article 6.2 International Registry have both the functionalities of: (a) holding and transferring ITMOs; and (b) “pulling-and-viewing” ITMO data? If so, what additional provisions are required to realize both functionalities?

Can we achieve the full operationalization of the Article 6.4 mechanism (The Paris Agreement Crediting Mechanism—PACM) by endorsing, through the respective CMA decision, the Supervisory Body's work and requesting it expedite its work?

## Adaptation

**Date:** October 1<sup>st</sup>, 2024.

**Involved Body:** SBI.

**Summary:** The report summarizes the events at the 46<sup>th</sup> meeting of the Least Developed Countries Expert Group (LEG), which took place from 19 to 22 August 2024. The meeting covered the least developed countries' priorities and needs for support, discussions with representatives of the Green Climate Fund and relevant organizations on providing support to the least developed countries, and the status of formulation and implementation of national adaptation plans in LDCs.

They include information on adaptation action undertaken, in progress, or planned as reported in adaptation-relevant national reports and communications submitted to the UNFCCC secretariat.

## Carbon Markets

**Event Type:** Publication.

**Subject:** Article 6.4 Mechanism standards.

**Date:** October 9<sup>th</sup>, 2024.

**Involved Body:** Article 6.4 Supervisory Body.

**Summary:** In its last meeting, Article 6.4 Supervisory Body adopted standards for methodologies (requirements for developing and assessing projects under the Paris Agreement Crediting Mechanism) and greenhouse gas removals (rules for projects that remove greenhouse gases from the atmosphere). These elements requested by the CMA were approved as 'Supervisory Body standards', and the SB requested the CMA to endorse this approach and provide any additional guidance. The objective is to ensure the mechanism can remain agile and adapt to future developments.

**Summary:** The Troika published a letter on its plan to foster dialogue on effective approaches to climate finance that can lead to actionable outcomes for developing countries. The discussion will focus on developing practical solutions to overcome identified challenges and barriers, such as high cost of capital and fiscal constraints in developing countries, in order to explore how climate finance can be mobilized effectively to support mitigation and adaptation efforts. The goal is to unlock the full potential of climate finance to drive progress on NDC and NAP implementation in developing countries. Such needs build on the outcomes of the first Global Stocktake.

This would be separate to outstanding negotiation issues around the New Collective Quantified Goal (NCQG) on climate finance.

The Troika invites participants to focus their interventions on the following areas:

How can climate finance be mobilized at scale to close the finance gaps identified by the GST outcomes?

How can climate finance effectively support the implementation of NDCs and NAPs, considering the barriers to climate finance and challenges faced by developing countries?

How can the growing adaptation finance gap be addressed and better aligned with the priorities of developing countries and broken down into manageable, investable steps to attract financing?

## Will happen in November

### General

**Date:** November 11<sup>th</sup>-22<sup>nd</sup>, 2024.

**Involved Body:** UNFCCC Secretariat.

**Summary:** Baku, Azerbaijan, will be the host to the Climate Change Conference, which includes the Twenty-ninth session of the Conference of the Parties of the UNFCCC (COP 29) and Sixth session of the Conference of the Parties of the Paris Agreement (CMA 6), as well as the Nineteenth Conference of the Parties of the Kyoto Protocol (CMP 19).

## Glossary

**Paris Agreement:** An international climate change treaty signed in 2015 and in effect since 2016. It is an implementation treaty linked to the UNFCCC.

**AILAC:** Independent Association of Latin America and the Caribbean. A group of countries.

**AOSIS:** Alliance of Small Island States. A group formed by small island countries.

**BASIC.** Group of countries composed by Brazil, China, India and South Africa.

**CMA:** Conference of the Parties to the Paris Agreement. The annual meeting of the Parties to the Paris Agreement to make implementation decisions for the treaty.

**COP:** Conference of the Parties to the UNFCCC. The annual meeting of the Parties to the UNFCCC to make implementation decisions for the treaty.

**FIG:** Environmental Integrity Group. A group of countries.

**FAO:** Food and Agriculture Organization of the United Nations.

**G77 + China:** Coalition of developing countries.

**LDC:** Least Developed Countries. A group formed by the least developed countries.

**LMDC:** Like-Minded Group of Developing Countries. A group formed by developing countries with similar views.

**NDC:** Nationally Determined Contribution, an individual document presented by the Parties to the Paris Agreement that contains the Party's contribution to preventing the Earth's temperature from rising more than 1.5°C above pre-industrial levels and achieving the objectives of the Paris Agreement.

**Party(ies):** Member country(ies) of the UNFCCC and the Paris Agreement.

**PCCB:** Paris Committee on Capacity-Building.

**SBI:** Subsidiary Body for Implementation.

**SBSTA:** Subsidiary Body for Scientific and Technological Advice.

**Stakeholders:** State or non-state actors, public or private entities, accredited or not as "observers" of the UNFCCC system, who have an interest in the negotiated topics.

**Submission:** A document in which an interested party presents their view on a specific discussion point in the negotiations, which may contain technical and scientific contributions, recommendations, and concrete proposals on how that discussion point should be addressed and resolved among the Parties in the negotiation.

**SUR:** A group of countries composed of Argentina, Brazil, Paraguay, and Uruguay.

**UNFCCC:** United Nations Framework Convention on Climate Change, or "Climate Convention," an international treaty signed in 1992, of which the Paris Agreement is a part.

The 2015 Paris Agreement is an almost universally adopted international treaty with 193 member countries. It is linked to the UNFCCC, an overarching international treaty system that provides broader principles, guidelines, and policies for the global community to cooperatively address the climate crisis. One of the main goals of the Agreement is to prevent the global temperature from rising above 1.5°C or to keep it well below 2°C above pre-industrial levels—a threshold that science has shown to be a "point of no return" with devastating effects on life on Earth. Additionally, the Paris Agreement aims to make countries resilient to climate change and to decarbonize financial flows.
